## FOR WHAT PURPOSE DO WE TRAT YOUR PERSONAL DATA?

At Playa y Fiesta SA, hereinafter, "Camping Playa y Fiesta" we treat the information provided to us by interested people in order to attend their queries, manage reservations, enable the execution of contracts, meet legal obligations established and in order to provide them with offers of products and services of their interest, as well as loyalty programs.

In order to offer you products and services according to your interests and improve your experience in Camping Playa and Fiesta, we will develop a business profile based on the information provided. No automated decisions will be made based on that profile.

## HOW LONG WILL WE KEEP YOUR DATA?

The data provided will be retained while the contractual or commercial relationship with the user is maintained and in any case, during the period necessary to comply with the legal obligations.

## WHAT IS THE LEGITIMATION FOR THE TREATMENT OF YOUR DATA?

The legal basis for the processing of your personal data is the execution of the contract between the parties, as well as the fulfillment of the established legal obligations.

The prospective offer of products and services is based on the consent requested of the interested party. This consent may be revoked at any time indicating by email to the address [responsable@campingplayayfiesta.com](mailto:responsable@campingplayayfiesta.com). And it does not condition the execution of the contract between the parties.

## WHICH RECIPIENTS WILL MY DATA BE COMMUNICATED TO?



The data shall not be communicated to third parties, except as regards the established legal obligations required.

However, we will count on the collaboration of third-party service providers who may have access to their personal data and who will treat the aforementioned data on behalf of us, as a result of their provision of services.

In particular, at Camping Playa y Fiesta, we will contract the provision of services by third party suppliers who carry out their activities, in the following sectors: legal advice, homologation of suppliers, multi-disciplinary professional service companies, maintenance-related companies, technology service providers, computer service providers, security companies, courier service Providers Snapshot, infrastructure management and maintenance companies and call Center service companies.

## WHAT ARE YOUR RIGHTS WHEN YOU PROVIDE US WITH YOUR DATA?

Everybody has the right to get confirmation on whether Camping Beach and Fiesta We are treating personal data that concern or not.

1. The persons concerned have the right to access their personal data, as well as to request the rectification of the inaccurate data or, where appropriate, to request its deletion when, among other reasons, the data are no longer necessary for the purposes that were collected.
2. In certain circumstances, interested parties may request the limitation of the processing of their data, in which case we will only retain them for the purposes of exercising or defending claims.
3. In certain circumstances and for reasons related to their particular situation, those concerned may object to the processing of their data. Camping Playa y Fiesta, will cease to treat the data, except for legitimate reasons compelling, or the exercise or defense of possible claims
4. People have the right to request the portability of the data if technically, this is possible and, in the event that the consent has been granted for any specific purpose, has the right to withdraw the consent at any time, without this affects the lawfulness of treatment based on prior consent to withdrawal.

The persons concerned may also at any time make a claim concerning the protection of their data before the competent Control authority.
